



#### CJI VOICES

Great reading today, so very true. Before OA I ate over every problem, trouble...issue no matter how big or small. I made it all very dramatic. Today I know without question that I can take anything to God and find a solution. How you ask? I've done it for every problem, and have found the solution, AND the solution was never ever food!

#### Example:

- 1. I had a miscarriage: I mourned, felt the feelings, and grieved the loss of my baby. I prayed, and thanked God for showing me I could in fact get pregnant after all the years of trying. I got pregnant again, and was able to actually enjoy the pregnancy every step of the way. There was no fear that I might miscarry again. I have 2 children:)
- 2. I was hospitalized with diverticulitis, followed with 6 long weeks of healing. I followed my doctor's directions...I prayed (lots and lots) and recovered without the need of surgery. I did not die.
- 3. I found a lump in my jaw, was tested, learned I needed major surgery. I breathed, I prayed, I followed my food plan, and set up the surgery. I learned I had cancer, but all was removed and nothing more needed to be done. I had partial paralysis in my face...I followed my doctor's directions, prayed and was patient....most of the feeling came back, and I recovered slowly, but surely. I did not die.
- 4. I went for a mamo, they found a suspicious mass. I did not freak out, I prayed and I made a follow up appointment. I meditated...often. The follow up appointment showed something new, that didn't appear to have any characteristics of cancer, but it was new, and different, so a biopsy was recommended. I did not eat over it. I made an appointment, and lived one day at a time. I did service, and continued to trust in God, and did the footwork. I went to my appointment and had the biopsy. I followed all the necessary directions, and I healed, while waiting for the biopsy results. I did not waiver from my food plan. I continued to trust in God and continued to do the footwork. The results were negative. had they been positive, I'd have done the same. I'd follow directions and do the next right thing. I pray, and mediate. I put my trust in God.
- 5. My son is being home schooled, and continues to have migraines. I pray daily. I take the best care of my son, as possible. I remain patient, and sometimes seem like a "bitch" to him. In reality, I know I am doing the best I can for him. I continue to do the next right thing, take it a day at a time, and trust that God already has the solution. I simply will remain vigilant, and know He has the answers. I will not eat over it, or treat my son unkindly. I continue to thank God for the help being given to us, and am patient, waiting for what will happen next.

This program proves to me, time and again that my HP already has the answers, and all I need do is continue to do the footwork. There truly is no problem I cannot take to God, and none for which God does not have a solution.
