

#### Board:

- Chair Terri B is rotating out after this assembly.
- The new chair is Rob L.
- Annmarie T has been voted in for her first full term as Treasurer.
- Leeann will be rotating out of her role as recording secretary after the assembly. Interested parties should review the Region's bylaws for position requirements and apply by 60 days prior to the next assembly.
- There is currently a vacancy for vice chair. Interested applicants should review the Region's bylaws for position requirements and apply by 60 days prior to the next assembly.
- Karen B. will rotate out of her position as Trustee in 2023 after the next assembly.

#### Trustee Report

- Per Karen's trustee report, West Virginia is forming an Intergroup that will be part of Region 7.
- World Services will participate in the International Eating Disorder Conference June 1-3, 2023. Regions will participate.
- Fundraiser magnet/pins to support our presentation at the IEDC.
- The price of literature will be increasing due to the cost of paper.

#### Treasurer Report:

- \$23,922 is the income for calendar year 2022 up until August.
- \$6,366.83 is the expenses for the calendar year 2022 up until August.
- Region is in good shape financially right now. This was confirmed by the Bylaw Committee.

#### Misc.:

- Region 7 is struggling for a quorum. There was a quorum on the first day but not the second. As a result, business almost canceled on the second day, however, after a second count business was able to be conducted.
- The theme of the assembly was encouraging people to do service. Region 7 believes that this is a consistent problem in the Region right now and hoped to provide attendees with ideas and solutions to bring back to their member intergroups.
- Intergroups (not individuals) can apply to Region 7 for assistance with funding WBSC travel by October 1.
- Funding for Region 7 assemblies are due 60 days prior to the region assembly.
- Applications for recording secretary and vice chair are due 60 days prior to the assembly.
- World Service Business Conference is in person only April 25-29, 2023 in Albuquerque.
- The current service challenge for intergroups is to have an in person workshop on any topic. The only requirement is that it is in person but it may be hybrid if the intergroup wishes.
- Board members are willing to speak at events.
- A workshop was held the second day to create action plans to promote service within member intergroups.

- Robin, Mike and Danielle worked together in this workshop with Toni Ann and Maria from North Jersey. Our idea was promoting service and the 7th tradition. Maria found a quote from OA.org: There is magic that happens when you give service to others; you wind up giving yourself a gift too.
- Our group discussed creating a model seventh tradition announcement.
- CJI won the workshop challenge for the workshop on service that Mike M. and Lucille organized. As a result, CJI received free registration to the next assembly.

#### Intergroup Renewal:

- Danielle is the Committee chair. Leeann and Karen B served as board liaisons.
- On October 26 at 12 PM there is a virtual “lunch and learn” type event wherein Kathy SG from South Jersey will teach groups about the ways that the chairs of North Jersey, Central Jersey and South Jersey have started an idea exchange meeting among the intergroup chairs.
- The group will be publishing the Stories of Service as a pamphlet. To serve a broader audience with different needs the group would like to also publish this as an E book with an audio component.

- Robin B. is on this committee.
- November 4-6 at Princess Royale Oceanfront Hotel in Ocean City, MD.
- We are expecting to operate at a loss. The Region is asking that member intergroups strongly promote this event within the fellowship.
- Price is \$85 and includes Saturday lunch and dinner only.

- There will be giveaways and entertainment.
- This committee would like CJI to donate a gift basket.
- This committee will take all of our unsold literature. Permanently.
